### INFORMATION NOTE

#### **For passengers traveling to the Republic of Suriname from or via The Netherlands**

The Ministry of Foreign Affairs, International Business and International Cooperation of the Republic of Suriname announces the following measures regarding traveling to Suriname.

Based on the most recent advice from the Health Authorities, the Government of the Republic of Suriname has decided, with a view to reduce the risk of cross-border spread of COVID-19, as well as to ensure the health and safety of international travelers/passengers, to close its International Airports.

However, starting **October 12, 2020**, **only one (1) Repatriation flight** will be allowed per week. The flag carrier airlines Surinam Airways (SLM) and the Royal Dutch Airways (KLM) will carry out the flights, in turn, between Suriname and The Netherlands.

#### **The following persons are allowed to travel to Suriname:**

- i. Holders of a Surinamese passport and foreign nationals with a valid Surinamese residence permit or foreign nationals with a valid PSA card.
- ii. Persons of Surinamese Origin who wish to travel due to a death of a 1<sup>st</sup> or 2<sup>nd</sup> degree family member. In this regard, submission of a death certificate and documented evidence indicating the family relationship with the deceased, are required.
- iii. Persons of Surinamese Origin who wish to travel due to serious and or terminal illness of a 1<sup>st</sup> or 2<sup>nd</sup> degree family member. It is necessary to submit a statement from a medical specialist and documented evidence indicating the family relationship with the patient.
- iv. Essential travel of persons to Suriname for serving the public interest, namely professional groups, diplomats and government officials.

Those who meet the above-mentioned requirements, may send an official request within ten (10) working days before the intended departure date via the e-mail address: [conza@gov.sr](mailto:conza@gov.sr)

#### **To travel to Suriname passengers are required to the following:**

- i. Present a negative **POLYMERASE CHAIN REACTION (PCR) COVID-19** test certificate, issued within 72 to 48 hours before departure time (this doesn't apply persons younger than 12 years old); only those travelers who test negative will be allowed to board the plane.
- ii. Be in possession of a health insurance certificate for coverage of all medical costs related to COVID-19, including the monitoring by the doctor during the quarantine period.  
In case the medical insurance does not cover COVID-19 related expenses, all costs associated with any treatment caused by COVID-19 will be borne by the passenger.
- iii. Upon arrival in Suriname a 10-day mandatory quarantine is required for all passengers at their own expense in a hotel recommended by the Health Authorities. For this purpose, a confirmed reservation must be shown at the counter of the airline the passenger is traveling with.
- iv. All the measures under i. to iii. also apply to Surinamese nationals and residents traveling back from or via The Netherlands.
- v. Diplomats and essential officials will be allowed a 10-day mandatory quarantine at home, based on the instructions from the Bureau for Healthcare (BOG), but must be able to present the required documents under i. and ii.

#### **Further information**

It is strongly recommended that passengers who intend to travel to Suriname take good notice of the aforementioned measures as well as other measures published by the Government of the Republic of Suriname or its Representations abroad.

If a passenger is unable to present a valid negative PCR COVID-19 test certificate and a confirmed hotel reservation, at the airport in The Netherlands, he or she will not be allowed to take the scheduled flight.
